Time to count from 1400 if NOR tendered before noon and from 0600hrs next working day if tendered afternoon. Based on the below SOF draw up a time sheet and calculate demurrage/despatch for that port.
- Vessel SOF reads as follows:  
Vessel anchored on Monday the 2nd April at 2200 hrs and NOR tendered  
Vessel berthed 3<sup>rd</sup> April 0400 hrs  
Commenced loading at 3<sup>rd</sup> April 0600 hrs  
Loading completed 5<sup>th</sup> April 1200hrs  
Vessel sailed 5<sup>th</sup> April 1500 hrs.  
On the 4<sup>th</sup> there was rain from 0830hrs to 1330hrs
